



# RELEASE AND WAIVER OF LIABILITY

I understand that this Release and Waiver of Liability Release is an important document related to my child's participation in the March of the Living to Poland and Israel, April 24 – May 8, 2022. (the "trip").

I acknowledge that (a) travel in general has risks; (b) there is heightened concern and risk of terrorist activities relating to travel in general in light of the events of the military campaign in Iraq and the events of September 11, 2001, especially with respect to air travel and international air travel in particular; (c) trip activities, including but not limited to sightseeing, bus, jeep and air travel, may be subject to certain hazards, both natural and man-made; and (d) with the current Israeli/Palestinian conflict and Israeli/Iran conflict, in recent years there has been an increase in acts of terrorism against individuals and civilians (which have included, among other incidents, indiscriminate bombings at public markets or other areas, bus stations, public buses, restaurants, coffee houses and hotels, as well as kidnappings and shootings) within Israel, and similar occurrences within Europe, including incidents at destinations frequented by tourists, and that these have resulted in injury or death to some Americans or other visitors to Israel and Europe. These incidents of violence have resulted in travel advisories by the U.S. State Department recommending against travel to Israel and increased risk in travel to and within Israel at this time.

Notwithstanding the above, I/my child will voluntarily participate in the trip and these activities with my knowledge, appreciation, and understanding of the dangers and risks involved. I hereby agree to accept and any and all risks of my child's participation in the trip. I understand the value of a trip to Poland and Israel, and further understand that the trip sponsors cannot bear or accept liability for the potential hazards that could, if such were to occur, subject trip sponsors to potential claims.

I also acknowledge that the International March of the Living has been able to obtain insurance insuring such agencies for liability with respect to such risks, and I acknowledge and agree that it is my personal responsibility to investigate and secure any medical life, liability, disability or other insurance that I determine is appropriate in my sole discretion.

I hereby acknowledge that I have had the opportunity to review this Release with legal counsel.

I therefore agree on behalf of myself, my heirs, next of kin, administrators, executors, guardians, trustees, successors and assigns, and any other representatives of mine, to the extent permitted by law, to release the trip's sponsors, including without limitation the International March of the Living, all related or affiliation entities, employees, officers, directors, managers, members, agents and volunteers and others involved in the trip either directly or indirectly ("Releases"), from any and all claims, liabilities, causes of action, rights to attach property attorneys fees and costs of suit, relating to or arising out of my child's participation in the trip or activities associated with the trip, including without limitation death, personal injury, incapacity, temporary or permanent disability, medical cost, expense, damage, claim, or other liability, however caused and regardless of whether caused directly or indirectly by their acts or the negligent or intentional acts of the Releases and/or others.

I expressly acknowledge that this Release is intended to include in its effect, without limitation, all claims which I may not know or suspect to exist against the Releases at the time of execution hereof, and that this Release results in the extinguishment of any such claim or claims. I understand and acknowledge that I may hereafter discover facts different from, or in addition-to, those which I know believe to be true with respect to all or any of the liabilities, claims, causes of action, costs, or demands herein released. Nevertheless, I agree that the releases set forth above shall be and remain effective in all respects, notwithstanding the discovery of such different or additional facts.

This Release supersedes and replaces all prior negotiations and all agreements proposed or otherwise, whether written or oral, concerning all subject matters covered herein. This instrument constitutes the entire agreement among the parties with respect to the subject matters discussed herein.

In case any one or more provisions contained in this Release shall, for any reason, be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision of this Release, but this Agreement shall be construed as if such, invalid, illegal, or unenforceable provision had never been contained herein.
